It aims to improve the health of local people in the city, addressing health inequalities by working as one team across traditional organisational boundaries.</li> <li>MLCO was formed on 1 April 2018 and is a partnership organisation powered by Manchester Primary Care Partnership.</li> <li>MLCO brings together the teams from these organisations that provide community-based care in the city in a new way. 	teams have now been deployed to MLCO. They include nurses, social workers, health visitors, therapists, support staff and many other health and care professionals. These teams are now working together as part of one single organisation for the first time. Through a neighbourhood-based approach, MLCO is empowering staff and communities to make changes to ensure that health and care services are the best they can be and that care is better coordinated around resident's needs. ## Julie Morgan AM

Julie Morgan was born in Cardiff and educated at Dinas Powys Primary School, Howell's School, King's College London, the University of Manchester and Cardiff University. She worked as a social worker and manager in South and West Glamorgan County Councils before becoming an Assistant Director at Barnardos. She was a councillor on South Glamorgan County Council until she was elected as MP for Cardiff North in 1997.

During her time in Westminster Julie presented 3 private members' bills - one on banning smoking in public places, one on granting votes at 16, and one on preventing under-18s from using sunbeds which became law in 2010. Julie was elected as the Assembly Member for Cardiff North in 2011 and was a member of the Public Accounts Committee, the Finance Committee and the Environment Committee during the Fourth Assembly, as well as chairing 7 cross-party groups covering areas such as children, cancer, and nursing and midwifery. In the Fifth Assembly, Julie was a member of the Health, Social Care and Sport Committee and the Children, Young People and Education Committee.

On 13 December 2018 Julie was appointed Deputy Minister for Health and Social Services.

## **Dr Dan Venables**

Dan graduated in psychology from Cardiff University in 1996, and later completed a Master's degree in forensic mental health and a Ph.D. in psychology. He has worked in NHS and private sector clinical psychology settings, in forensic mental health and in community learning disabilities services. Dan's research career includes UK energy policy as well as social care and health research. He is a former chair of the UK Ageing Research Forum and has held positions at Cardiff and Manchester Universities, the Arthritis Research Campaign and the Personal Social Services Research Unit at Manchester.

Dan joined the Welsh Government in 2010 where he is Head of Social Care R&D at Health and Care Research Wales. Dan is responsible for social care R&D policy and funding strategy across Wales. His remit is to develop and fund strategies and initiatives to increase the quantity and quality of social care research; and to promote and facilitate evidence-enriched social care practice in Wales

### Dr Lisa Trigg

Lisa is Assistant Director, Research, Data and Intelligence at Social Care Wales. Her role is to support the social care sector in Wales through the development of a high-quality data, evidence and intelligence function. Prior to this, she spent seven years at the London School of Economics conducting research into social care, and specifically into quality and regulation in social care. Much of this research involved comparing the approaches of different governments, including the systems of several European countries, as well as Australia, Japan and the United States. Before this, Lisa spent seventeen years working in management and consulting roles in Australia and the UK, with clients from a range of sectors, including telecommunications, media, IT, financial services, utilities and the NHS.

## **Richenda Leonard**

Richenda is the senior project officer for the Wales School for Social Care Research. She has a background in Anthropology and has worked previously in the third sector and with refugee and asylum-seeking communities.

### **Steff Watts**

Stephanie works in a Research Development role and as the national coordinator of the Enabling Research in Care Homes network across Wales. Stephanie is a graduate from the University of Bath (BSc Psychology) and Bangor University (MSc Foundations of Clinical Psychology). Stephanie has worked in several research and clinical roles with children and families at the Centre for Evidence Based Early Intervention (Bangor), and in a community mental health team in North Wales.

#### Jon Smart

Jon is Head of Programmes at Swansea University Data Science and Chief Operating Officer of the SAIL Databank. He manages a large portfolio of UK data investments by research councils and government. These investments focus on undertaking linked data research for societal benefit. The teams of researchers he manages work directly with the NHS, local authorities, devolved and UK government to produce outputs to support their work.

Jon has a background in programme and project management, is a Fellow of the Chartered Management Institute, and has 20 years' experience managing large programmes and projects across the UK and internationally.

#### Jonathan Morgan

Jonathan is Head of the ADSS Cymru Business Unit and is leading the organisation's engagement with Welsh Government and other strategic partners in preparing for the United Kingdom's exit from the European Union. An Assembly Member for 12 years prior to joining Practice Solutions Ltd in 2011, he is also currently the Chair of the Public Service Ombudsman's Audit & Risk Assurance Committee, Chair of the Ombudsman's Advisory Panel, and a member of the Future Generations Commissioner's Audit Committee.

#### **Bernadette Enright**

Bernie has been working in social care for over 30 years, beginning her social work career in Hope Hospital, Salford in 1984, from where she went on to work within a wide range of service areas. This included roles as a Mental Health Social Worker, Team Manager of an Adults and Older People Team, and Principal Manager of the Joint Service for People with Learning Disabilities. She then went on to undertake the roles of Head of Social Work and Assistant Director.

In 2016, she took on the role of Director of Social Care and transferred, along with 440 adult social care staff, from Salford City Council into an Integrated Care Organisation hosted by Salford Royal NHS Foundation Trust. Working in Salford gave her the opportunity to be at the forefront, regionally and nationally, of health and social care integration. From her experience she believes that integrated care gives us so many opportunities to improve services, design new care pathways and support people closer to home.

In 2018 she moved to Manchester as Director of Adult Services in Manchester Local Care Organisation, joining them on the exciting journey of integrating health and social care and hopes to be able to use what she learned in Salford to contribute to the positive change already taking place in the City.

Bernie has always had a person-centred, asset based, approach which keeps people at the heart of everything we do. She firmly believes that working collaboratively, thinking differently and - most importantly - developing and supporting staff, will enable us to make improvements to the health and wellbeing of citizens, supporting them to have better outcomes in their lives.

### **Joanne Chilton**

Joanne is a passionate and accomplished strategic leader in the social care, health, housing, employment and community sectors. She has worked for over 25 years as provider, commissioner and strategy developer in the public and private sectors and more recently with the Greater Manchester Health and Social Care Partnership as Programme Director for the Adult Social Care Transformation Programme. She was also Head of Strategic Commissioning in a Local Authority responsible for all adult social care commissioning and service development.
